



Minutes of the
Fourth Division Council Meeting of the

Lt. Governor Pat Lane called the meeting to order at 7:04 PM and welcomed all in attendance.

Opening remarks of the Lt. Governor: Lt. Governor Pat Lane repeated her offer to attend as many of the clubs' activities as she is aware of, "Let me know about it and I'll be there." She then reviewed the anticipated attendance at the upcoming Toronto International Convention. Other than the Rensselaer club, all clubs have registered two delegates to represent them at the convention.

Previous minutes (March 16, 2016): The previous minutes were accepted as published on a voice vote.

Treasurer's Report: Treasurer Bob Pasquarelli presented his report (one error was noted – the expense for the RADARC Coalition – Anti-Heroin & Opioid presentation "Rensselaer High School" should read \$1000 rather than \$1800. A corrected copy is attached to these minutes.) The report was accepted on a voice vote.

Report of the Key Club Lt. Governor: Lt. Governor Jordan Scott noted that two-thirds of the Key Clubs in the division had filed their election reports. She reported that she would be unable to attend the Orlando Key Club International Convention. She offered to encourage the local Key Clubs to help the sponsoring Kiwanis clubs with their projects.

Remarks of the New York District Candidate for Governor Elect: PDLG Candace Corsaro thanked the division for the invitation to address the clubs. She then outlined her campaign.

Governor's & First Lady's Projects: Lt. Governor Pat Lane urged the clubs to report their activities concerning the Governor's and First Lady's projects and noted that the appropriate report forms were included in the meeting packets.

2016 Golf Outing: PDLG Bob Loveridge reviewed the preparations for the June 11 Division Golf Outing. He requested that the clubs encourage as many to register for the events as they can. He also requested the help of those who were no golfing and would like to help at the outing.

Old Business:

Donation to support “Weekend Food Backpacks” Project – submitted by PDLG Wendy Prout. This had been tabled for more information. PDLG Wendy Prout emailed the following: “I will not be at the Division Council Meeting this week. I do want to give a follow up to the Backpack Food Program that I presented last month. I was asked by the Division if they would take a donation for 1 year. Yes they would. They are in conversation with Poestenkill Elementary at this time. I know of some local schools who participate and the children really look forward to it. School Districts that are involved with a Backpack program are Rensselaer, Castleton, Troy, Brittonkill and Hoosick Falls. The request was for \$2500 for 3 years but they would take 1 year of funding.”

A motion was made and seconded to provide a \$2500 donation to the program. As many attending the meeting had not been at the previous meeting, there were many questions.

A motion to table until the next meeting in order for this to be taken back to the individual clubs for their input was made and seconded. The motion was tabled on a voice vote.

New Business – Lt. Governor Pat Lane

Support for the Key Club Lt. Govern and CKI Lt. Governor attending the International Conventions.

Lt. Governor Jordan informed the meeting that she would not be attending the Key Club Convention. As Lt. Governor Brian was not present a motion to support him with a \$300 stipend if he were to attend the CKI Convention was made, seconded and passed on a voice vote.

Other New Business: None

Theater Outing – PDLG Jean Andrick reviewed the plans for this year’s outing. A flyer for the event was included in the packets. She noted that the event would be canceled if there was no interest.

Next Division Council meeting – Kiwanis Club of Troy – Sunday, July 24, 2016 – Joe Bruno Stadium ValleyCats Outing/Eliminate Fund Raiser. PP Michelle Skinner reported on the event and provided a flyer to each club.
