Call to Order and Welcome: At 7:15 PM Lt. Governor Harleen called the meeting to order and welcome all remarking that she was pleased by the wonderful turn out.

Treasurer’s Report: after a presentation by the Treasurer the report (a copy attached) was accepted for filing on a voice vote.

Guest Speaker: Ed & Laurie Andrick discussed the problems raising a loving autistic child and the various support groups.

Lt. Governor Harleen noted that all the information is tentative and urged each club to share the information of their installation with the other clubs as soon as it is finalized. She also noted that interclubbing will be a very important part of her 2013-14 administrative year and very strongly urged the clubs to support each other by interclubbing to as many of the installations as they can.

2013-14 Van Rensselaer Interclub Award Program: Lt. Governor Harleen reported that she was developing a Division Interclub Award program which she will report on in more detail at a later meeting.

Distribution of new material for the “Club Secretary Resources” notebooks: Secretary David distributed to those clubs present the materials for the “Club Secretary Resources” notebook that Kiwanis International had produced. He informed the club’s that KI intended that this be a permanent document passed on from one club secretary to their successor. The material is intended to be place in a three ring binder. In addition to keeping the secretaries’ records the notebooks are to be used at the annual secretaries training and will be updated from time to time with inserts/replacement pages. He also called the clubs’ attention to the fact that effective October 1st the prorated new member add fee schedule will no longer used rather KI has adopted a flat \$50 new member add fee for all new members added in @013-14 regardless of when they join a club.

Discussion of the use of the “Golf Money:” IPDLG Bob reported to the clubs that there was approximately \$4,100 raised by the two golf outings, split between the Administrative Fund and the Programs Fund. He request that the clubs consider how the Division can best use the funds. Several suggestions were made: increase the Lt. Governor’s discretionary fund; offer a \$50 offset for new members toward their first full year’s dues; make donations to local food pantries and make a onetime donation to the Eliminate Project. Lt. Governor Harleen asked the clubs to “do their homework” and bring suggestions to the next meeting.

2013-14 Division Committee Appointments: Lt. Governor Harleen requested that anyone who would like to serve on a division committee or chair a committee contact her.

New Business: Eliminate Multi-division Coordinator Lynne asked that the club’s urge that their Sponsored Leadership Program organizations participate in the upcoming Halloween “Trick or Treat for UNICEF” program.

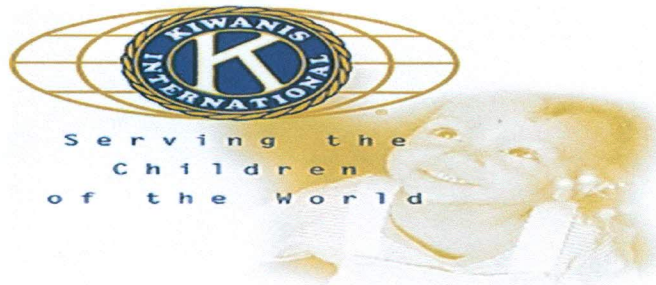
