

# Kiwanis Club of Sand Lake



## **Summerfest 2011 Application for a Food Vendor Permit**

A Food Vendor Permit is required by concession operators for the sale of food and/or beverages at the 2011 Sand Lake Kiwanis Summerfest, scheduled for July 1-4 at Butler Park and on the grounds of Averill Park HS in Averill Park, N.Y. If the application is approved, the undersigned may offer the approved items, and only the approved items, for sale on any or all three days of the Summerfest: July 1-4, 2007. Cost of the Food Vendor Permit is \$200.00.

### Terms

No food vendor will be allowed to sell food at the locations or on the dates listed above unless the Kiwanis Club has approved their application.

All vendors approved to sell products at Summerfest 2011 must also have a valid certificate of insurance. The certificate should name the Kiwanis Club of Sand Lake, NY, Inc. and must be received before Summerfest. The Town of Sand Lake, NY requires a separate certificate of insurance.

Food vendors are required to provide a descriptive list of food and/or beverage items to be offered for sale along with portion size and prices. The descriptive list is to be written on, or supplied as an attachment to, this Application for a Food Vendor Permit (see below). No food and/or beverage may be offered for sale unless approved the Sand Lake Kiwanis. No food and/or beverage of similar quality and quantity may be sold a price lower than that offered by the Sand Lake Kiwanis.

All vendor vehicles must be "out of the park" no later than 10 AM each day and no vehicle will be allowed to enter the park grounds without the consent of the Summerfest

Coordinator. To enter the park grounds all vehicles must display the permit issued by the Coordinator on the dashboard.

All vendors must be issued a "Sand Lake Kiwanis Vendor Permit" and have it available in their booth.

**This Application for a Food Vendor Permit, a check for \$200.00, a certificate of insurance naming the Kiwanis Club of Sand Lake, NY, Inc. as the holder and a copy of the Food Service Permit issued by Rensselaer County are to be submitted to the Kiwanis Club of Sand Lake no later than June 7, 2011.**  
**Return to the Kiwanis Club of Sand Lake, PO Box 535, West Sand Lake, NY 12196**

The Kiwanis Club of Sand Lake will designate assigned locations to approved vendors.

If the application is not accepted, the vendor fee will be returned to the concession operator prior to the start of the 2011 Sand Lake Kiwanis Summerfest. The decisions of the Sand Lake Kiwanis are final.

Any concession operator who fails to comply with these terms and conditions or engages in the sale of food and/or beverages other than those approved by the Sand Lake Kiwanis will be asked to leave Butler Park/APHS (the permit fee will not be refunded) and, if need be, the matter referred to law enforcement.
